## Student Account Services – Ways to Pay Your Bill

Study Abroad for Fall 2025 deadline is March 15th! Your student account must be up to date to register for Summer and Fall classes. A hold will be placed on your account if you owe money from previous terms. Update on credit/debit card payments. The convenience fee is 2.65% effective March 1, 2024. Please monitor your EU email for important notifications and balance due reminders from Student Accounts. Stop in or schedule a virtual appointment to discuss your account, make a payment or discuss payment plans. If you have a balance due now on your Student Account bill or you are anticipating a future balance in an upcoming term, check out these options:
